RSU #10 Report: Charles Maddaus

Charles Maddaus announced that he will resign effective as July 31, 2021 and is willing to assist in replacement and training.

Winter Roads Contract Bids

One bid was received from New England Custom Builders and Johnson Excavation submitted letter stating he would consider bidding if the contracts requirement to additionally insure the town was removed and the sand stockpile maintenance was put out to bid as a separate contract. The received bid was rejected. The contract will be modified to remove additionally insured requirement and create a separate sand contract. Plow bids due by 7/9/2021 and sand bids due by 7/23/21. Motioned by Haxton, seconded by Hinshaw, and voted.

Culverts on Bonney Road will be replaced starting June 28th through the end of July starting at the Buckfield town line. Sullivan will send email out to town stating that there will be delays.

New Business:

The salt bid/award is complete. The Town of Sumner was awarded 1,450 tons at \$59.25 a ton. Maximum ton of 1,450 is available but not required to be used by town. Wickson estimates a total of 1,350 will be used.

Sullivan suggested exploring a new fee schedule to increase building notification fees and other various sources of revenue for the town. Sullivan will research surrounding towns and update the board with findings. A meeting with the Planning Board will be necessary to discuss increases on notification fees.

The Board of Selectmen requested a quarterly update from the Planning Board to occur July 13, 2021.
